## What is RC&D

### **Resource Conservation and Development**

RC&D areas were established in the Agriculture Act of 1962 to provide a program that empowered rural people to help themselves. The Jackson Purchase RC&D was authorized as an official RC&D area in 1998 through an application to the USDA Secretary of Agriculture. The Foundation is a nonprofit, non-governmental, 501(c)(3) tax-exempt organization. This standing makes them eligible to secure grant funds from private foundations and others, to receive private individual donations, to become holders of property, etc., as allowed by the law. The Jackson Purchase RC&D serves the Kentucky counties of Ballard, Calloway, Carlisle, Fulton, Graves, Hickman, Marshall, and McCracken. Specific areas of interest were established by the Board of Directors to focus the resources available and those provided by the United States Department of Agriculture's Resource Conservation and Development program, administered by the Natural Resources Conservation Service. RC&Ds are not entities of government; therefore the usual policies and constraints of local, state, and federal government programs do not limit them in the kinds of issues they decide to address or how they decide to do it. Local people on the Council determine the types of concerns, projects and activities in which the RC&D will become involved.

## Our History

The first actions to establish the Jackson Purchase Resource Conservation and Development Foundation, Inc. were taken in the fall of 1994. At the time, there were 243 designated RC&D areas in the United States, ten of which were in Kentucky.

The first official Board of Directors meeting was held November 30, 1994. An application was submitted to the IRS for Non-profit community foundation status as a 501(c) (3) and was awarded in April 1995. The United States Department of Agriculture Natural Resources Conservation Service assigned an RC&D Coordinator in October 1995 to assist the Foundation in its natural resource conservation efforts and community development activities.

The Application to the Secretary for official RC&D area status was originally submitted April 19, 1995. A revised application was submitted on September 30, 1997. The Jackson Purchase was designated as an official Resource Conservation and Development Area by the Secretary of Agriculture on March 17, 1998.

There are currently 375 designated RC&D areas and 35 applicant areas across the United States. The state of Kentucky is now covered by 14 authorized areas. The Jackson Purchase Resource Conservation and Development Foundation, Inc. is a nonprofit, non-governmental corporation serving the Kentucky counties of Ballard, Calloway, Carlisle, Fulton, Graves, Hickman, Marshall, and McCracken.

In 2005, the Foundation was accepted into the Circle of Diamonds Program, a program through the National Associations of RC&D Councils, that is designed to highlight those RC&D Councils that show exemplary public accountability and have produced high quality programs within their local community. This mark of excellence will assist the Foundation in showcasing itself to the Jackson Purchase communities, other Councils, and the Nation.

### Land Management

**Clarks River Trail Project Phase 1**—This trails project is a partnership between the US Fish and Wildlife Service's Clarks River Wildlife Refuge and Marshall County Fiscal Court. The Foundation assisted with grant development for the National Recreational Trails Program and assisted with project coordination. The project consists of a paved loop trail for pedestrians, bicyclists, and wheelchairs that joins with a gravel trail for use by walkers, joggers, and bicyclists. Both trails have wildlife viewing

stations along their paths. There is also an observation tower and shallow water areas for wildlife. Trail construction is complete except for the paving and the signage and viewing facilities are constructed.

**POWER** (Promoting Our Wildlife & Energy Resources) Program— The program is a cooperative effort between Kentucky utility companies partnering with the Kentucky Department of Fish & Wildlife Resources, NRCS, Conservation Dis-



tricts, and RC&D Councils. It is aimed at adapting existing right-of-way management activities to benefit wildlife, customers, and utilities. Benefits include enhanced wildlife habitat, improved public relations, and lower line maintenance costs. Groundwork has been laid with the power providers and demonstration projects began in 2006.

**Precision Agriculture BMP Technology**—Precision Agriculture, funded with a 319(h) Nonpoint Source Pollution Control Grant through the Division of Water, is a process where farmers apply the required soil amendments according to the need and potential production of each acre instead of applying these on the average across their fields. The Foundation established a cost-share program with 40 farmers in the Jackson Purchase to encourage grain farmers to purchase the necessary GPS (Global Positioning System) and accessories and sign up with technical service providers for data analysis and develop integrated crop management for their entire operations. This was the second year of data collection in the four years necessary to complete the project. All forty participants have continued to work with the coordinator for the project, Dustin Renfrow

**Woody Biomass Utilization**—this project is a cooperative effort between Kentucky Division of Forestry and USDA Forest Service Land Between the Lakes National Recreation area with a private business, G&C Multi-Services, LLC and JPF. To obtain equipment and labor to establish a system to harvest, collect, sort and process small diameter timber and urban/suburban wood waste into pellets for an alternative energy source. A grant application was submitted to the USDA Forest Products Laboratory but was not funded this year.

### Water Management

Aquaculture Revolving Fund— This loan fund was established to provide monetary assistance to entities interested in aquaculture ventures at a low interest rate. As the fund is repaid, it will again be loaned to additional entrepreneurs. Currently all funds are loaned out.

Aquatic Restoration of Three Mississippi River Tributaries—The purpose of this project is to restore aquatic habitat for four federal endangered species and eighteen state threatened or endangered species in three Mississippi River tributaries (Bayou de Chien, Terrapin Creek, and Obion Creek watersheds) in the Jackson Purchase area of Western Kentucky. Funding is from a Private Stewardship Grant through the U.S. Department of Interior, Fish and Wildlife Service. While this project is fully funded actual work on the landowners projects will not begin until 2007.

**Four Rivers Basin Team 2008**—JPF, the Kentucky Division of Water and many others, partnered to form the Four Rivers Basin Team in 1999. The Team addresses various watershed issues and compiles information into reports available to the public and distributes to water resource management agencies to further assist in proper watershed management and water quality monitoring. In 2006, Robert Wise, the Four Rivers Basin Team Coordinator retired after six years of service to the team. Janet Miller became the new Basin Team Coordinator. Last year, the Four Rivers Basin Team worked closely with the Four Rivers Watershed Watch, Pirates Cove Cluster Septic System Demonstration Project, Cane Creek Watershed-Based Plan and Upper Clarks River Watershed-Plan Projects. Team members supported the following other activities: Livingston Creek study; TMDL Development on Clarks River; Cumberland River Compact's Building Outside the Box Project on Pleasant Grove Creek, a tributary of Red River; worked with the Nature Conservancy on project areas, Grand River Corridor and Obion/Bayou de Chien.

**Four Rivers Watershed Watch 2006**—The Watershed Watch program has completed its seventh year. It was originally started with the Kentucky Division of Water through outreach efforts to each section of the state to focus on community based stream assessment programs. With the continued assistance of volunteer teams, this program conducts visual surveys and collect water samples from 114 various sites across 17 counties for lab analysis from streams and rivers in Western Kentucky. Special studies were completed on Red Duck Creek in partnership with Murray State University and on Obion Creek and Bayou de Chien. A fall conference was held in November for networking purposes so that all volunteers could compare the results of their water testing and discuss future efforts for monitoring and clean up of any affected areas. Coordinators for this project are Dr. Joe Baust, Karla Johnston, and Ken Cooke. Results are available at http://kywaters.org/watch/fourrivers/.

**Obion Creek Stream Corridor Restoration Project Phase II**—The purpose of this project is to reduce sedimentation by restoring the stream channel dimensions, flow patterns, and profile to those of the natural stream flow conditions. This project will address the Obion Creek section which is upstream from the stream restoration completed in 2004. The Foundation has facilitated funding from the Kentucky Department of Transportation, through the Hickman County Fiscal Court and from the Mitigation Review Team. Also, a grant proposal to the Kentucky Division of Water were submitted but not funded. All the income sources are necessary to complete this extensive project so no work has began. Engineering will be done by the University of Louisville. Further funding will be sought. Work will begin when the last piece for the funding secured.

### Water Management

**Pirates Cove Cluster System Sewage Disposal Demonstration**—In 2006, the construction of a cluster sewage system in Pirates Cove along Kentucky Lake was completed which includes the connection of 100 residences, RV sites, and others. This demonstration and education project was the first such project located in western Kentucky and served as an excellent learning tool for septic system installers and homeowners. The Jackson Purchase RC&D, Marshall County Health Department, Tennessee Val-

ley Authority, and the Pirates Cove Home Owners Association partnered in this endeavor. Two workshop/ field days were held to show the completed project and to educate homeowners and the general public about the project. The final report is on the Foundation web site.

**Pirates Cove Homeowners Fund**—Is the Maintenance/Sinking Fund of the Pirates Cove Homeowners Association. The fund currently holds \$47,910.00. This fund meets the State's requirements for a sinking fund an allows for funds to expand the system in future.



**Sediment Survey of Lower East Fork of Clarks River**—This purpose of this project is to produce a survey to establish a benchmark of sediment deposition in the floodplain along the East Fork of Clarks River in the National Wildlife Refuge. The survey will address regional environmental priorities in western Kentucky related to watershed protection, agriculture, and healthy communities. The grant proposal was not funded.

**Storm Drain Stenciling 2006**—The purpose of this project is to create public awareness of the need to keep pollution from entering the storm drains which endangers the public water supply. Drains are stenciled with a notice of pollution hazard from dumping substances into the drains. Mayfield and Murray participated in 2006.

**Watershed Based Plan for Cane Creek of Bayou de Chien**—involves many of the agencies and groups dealing with water quality. This project is funded by EPA 319(h) to develop a Watershed Based Plan for Cane Creek, a tributary of Bayou de Chien. MSU Hancock Biological Station, Fulton and Hickman County Conservation District partner in this project. The idea is to develop a comprehensive approach to water quality improvement for the entire watershed, across county lines. In 2006, the first Wet Weather sampling was completed and two regular samplings were completed. The actual plan will be developed in 2007.

**Watershed Based Plan in Upper East Fork Clarks River**—involves many of the agencies and groups dealing with water quality. This project is funded by EPA 319(h) grant to develop a Watershed Based Plan for a portion of the Clarks River Watershed. The Hancock Biological Station and Calloway County Conservation District are partners in this project, providing technical assistance in the watershed. The idea is to develop a comprehensive approach to water quality for the entire watershed.

### **Community Development**

**Agriculture Development Funds**—The Foundation is assisting County Agricultural Development Councils with the distribution of Tobacco Master Settlement Agreement funds to local producers. Following are cost-share programs the Foundation administered in 2006:

Ballard County—Hay, Straw, & Commodity Storage 2, Livestock Fencing Improvement;

Calloway County-Hay, Straw, & Commodity Storage Facilities

Graves County-Agricultural Technology, Hay, Straw, & Commodity Storage;

Hickman County—Beef Genetics Improvement 2;

McCracken County—Agricultural Technology, Cattle Handling 2, Hay, Straw, & Commodity Storage 3,

The Jackson Purchase RC&D has received a total of \$1.8 Million toward these farmer reimbursable cost-share programs over the years. During 2006, we received \$370,946 from the Governor's Office of Agricultural Policy and awarded \$288,649 to 90 farmers to increase their income potential and reduce their dependence on tobacco.

**Calloway County Environmental Studies Project**—JPF assisted the Calloway County Conservation District in preparing a grant for an outdoor classroom for Calloway County Schools. The grant was funded through the Kentucky Division of Forestry, Urban and Community Forestry Grant Program. The trail has been completed and most of the plantings installed.

**Back Pack Provisions, a Youth DEAL project**—this project provides food for underprivileged students over the weekends for when they who would most likely do without meals due to home environments. Ten students were given backpacks with weekly food stuffs.

**Challenging All Tasks (CATS), a Youth DEAL project**—this project provides a summer reading, math and spelling program for at-risk 3rd graders.

**FBLA National Leadership Conference, a Youth DEAL project**—this project assisted 56 high school FBLA students with attendance at their national conference in Orlando, Florida. This money allowed 7 students to attend the National Conference that otherwise would not have been able to attend.

GCHS Freshman Mentoring Program 2, a Youth DEAL project—this project utilizes Juniors and Seniors to mentor incoming freshmen for the purpose of developing nurturing and respectful relationships. Forty students participated in this program.

**Mayfield Middle School Character Club, a Youth DEAL project**—Fifteen students benefited from this youth leadership development program for middle school students.

**Mayfield/Graves Co. High School Youth Leadership Program, a Youth DEAL project** this project is for a youth leadership development program for high school students. Twenty-Six students form both High School participated in this year long project.

### **Community Development**

**NARCDC List Server**—The partnership of the Jackson Purchase RC&D Foundation and the Ore-Cal RC&D in California shares the workload of operation, technical support, and the maintenance of internet list servers, email, file sharing and chat rooms availability. The agreement is to maintain the list server through Ya-hoogroups.com. It began July 1, 2001 and has continued through 2006. Coordinators for this project are Lisa Rowton and Donna Burcher.

**NARCDC Website**—in March 2006, JPF began management of the website representing the National Association of RC&D Councils. The project includes maintenance of the home page, and keeping website information current. This project will continue until April 2007.



Handicapped RAMP project—this project provides handicap accessible ramps to local individuals who cannot afford to purchase a ramp and who do not qualify for funding through any other sources. In 2006, JPF worked with a group of local volunteers to build ramps. Funding for this project was provided in part through a grant from the Honorable Order of Kentucky Colonels and through individual contributions. Reidland United Methodist Men constructed one ramp before the end of the year. Twenty more are planned.



Youth DEAL, Inc.—A gift from Pilgrim's Pride Poultry established the Fund for Youth Development. This fund includes a program for life skills, and leadership development for the youth in Graves County. Mentoring programs, leadership and employment training are program focuses of Youth DEAL. Inc. Of each vearly contribution, half is used to support local programs; the remaining half is entered into an endowment fund to support future youth programs and ensure perpetuity of the Fund for Youth Development.

#### Upper East Fork Clarks River WBP-BMP Implementation-

This project, funded through an EPA 319 grant, will address significant sources of pollution, develop practical solutions, and prioritize projects for implementation for both impaired stream reaches and the not-listed sections of this watershed. The goal is to improve the habitat for all other species, improve the water quality, reduce the threat of nonpoint source pollution from all sources in the tributaries and main stem of the upper East Fork Clarks River watershed making it safe for overall recreation and aquatic life.
